- 7. Providing continuity and consistency between the interactions with the Board and the staff.

- Provide oversight and guidance for staff, committees, and volunteers
- Responsible for the overall personnel policy, hiring of competent staff, salary administration and staff accountability
- Ensure all legal and tax filings are current
- Development and oversight of annual budget; implement changes necessary to assure a positive cash flow.
- Provide regular reports to the Board of Directors on the actions and activities of the home office
- Attend all meetings of the Board of Directors, assist with developing agendas and materials needed
- Execute and implement Board decisions
- Proactively bring ideas for service and program improvements to the Board
- Meetings management including hotel contract negotiations, budgeting, and catering arrangements
